Having a Master Herbalist background will give you the additional knowledge and confidence to handle the many clients that have already tried everything else with no results.

The American Association of Drugless Practitioners Certification and Accreditation Board provides full board professional accreditation and certification to both institutes of higher education and professional practitioners. Students who have received their diplomas are encouraged to apply at www.aadp.net.

Our Holistic Health Professional program is identical to our Doctor of Traditional Naturopathy program. The name difference is in response to the ongoing legal/political issues. If you are concerned about laws developing in your state, or live in a state where the wording "Doctor of Traditional Naturopathy" may bring legal issues, please choose the HHP designation/program. In the end it is WHAT WE DO, not what we call ourselves.

Requirements include 20 books, 3 projects, 7 Study Groups and a dissertation. Estimated time to complete this program is 26 months. 100 credit hours/1600 study hours. The estimated time is a guideline. It is possible to finish much earlier if you have the time to devote to your studies. Some students will need to extend the time by several months.

Prerequisites

We require the minimum of a high school diploma or GED to enroll in any program at Genesis. If a student is from outside the U.S. we will need a description of your educational background. Students are NOT required to have a college degree. Genesis School of Natural Health has a nondiscriminatory policy. We do not discriminate period! We exist to teach and train all those interested in the field of natural health. Legally we would say that we do not discriminate on the basis of gender, race, religion, or national origin.

Distance Education Requirements

1. You should have basic computer skills - you will need to know how to use email, attach files, access the Internet, and how to utilize word processing.
2. Students are required to have a desktop or laptop computer in their own home - Mac or PC. This computer must have an enabled sound card, speakers and a microphone (most newer models will have these requirements built in).
3. Students need a Broadband Internet connection such as Cable or DSL.
4. A personal email address is required - this must not be shared with a spouse or other family members. If your email contact changes you must notify us immediately - send us an email using your new address with the Subject stating "NEW EMAIL ADDRESS".
5. Students must download the free software programs provided for classes. GoToMeeting and Adobe Reader are free and necessary for all educational programs.

Testing, Projects, and Study Group Methods

Tests are open book and primarily fill-in-the blank and true/false. The purpose of testing is for emphasizing information and ensuring that each student has read the required materials. Projects are graded as a pass or fail. If a project is not adequate the student will be given additional instructions before resubmitting the project. Study Groups will develop each student's critical thinking skills and expand their client communication skills. Case studies are an excellent tool for learning how to apply herbs, homeopathics, nutrition, and other natural healing methods to specific individuals.

Application, Registration and Fees

The first step is to submit the online student application form. Registration requires a completed application and acceptance into the program of choice. We will review your application and schedule an appointment to help you with any additional documentation that may be necessary to approve your registration. There is a \$150 non-refundable application fee which is included in the tuition prices. The fee per credit hour is \$40.00.

After your registration is approved you will receive a student package with all the information you will need for downloading Study Group materials, tests, and for completing the Student Profile. We require a completed Student Profile and a small photograph for each student's file. The information in the Student Profile and the picture are for office use only - we will not publish or share student information with anyone. **The Student Profile is due before starting Phase One Study Groups.**

All textbooks and CD/DVDs are the responsibility of the student and are available at many online bookstores. Study Group downloads are included in the tuition. An installment plan for all programs is available. Credit cards, personal checks and money orders are accepted for tuition payment and must be in U.S. Dollars. Genesis does not participate in Federal or State financial aid programs.

Refund Policy

Students who withdraw from their program of study within the first 60 days will receive a full refund on the tuition paid for their program, minus the \$150.00 nonrefundable application fee and the fee for any completed courses. If you have given Genesis School of Natural Health authorization to process your credit card we will continue to do so until the full tuition is paid unless you formally withdraw from your program within the first 60 days. Stopping payments or course work is not considered an official withdrawal from the school. You must contact our office to withdraw from any program or class.

Transfer of Credits

Transfer of credits/classes from another school is allowed but it will be done on an individual basis. There are no fees for the transfer of classes - we are pleased that you have chosen to continue your education at our school.

Will my transcripts be accepted at other schools for credit?

It totally depends on the school. Genesis does not have government accreditation (this is true for most natural health online programs including Trinity, New Eden, and many more). Professional accreditation is recognition by professionals which is not the same as a government accredited college or university.

Licensure

A few states require a license to work in specific areas of the natural health field. Genesis School of Natural Health does not meet the educational requirement of any state where a license is required. It is the student's responsibility to find out the individual requirements of your state so you are in compliance with their laws. Our online distance learning programs lead to non-traditional diplomas and designations. Genesis School of Natural Health does not have, nor do we plan, to seek accreditation through the U.S. Department of Education.

Genesis School of Natural Health has avoided any known language that may become an issue as the medical profession and drug companies try to limit our access to natural health consultants and natural products.

We do not offer a Doctor of Naturopathy diploma or degree. It is called Doctor of Traditional Naturopathy. You may choose the recognition as Holistic Health Professional for the same program. If you choose the TND program and later find out that this was not a wise decision we will give you a new diploma stating you are a HHP (a fee for a new transcript and new diploma will apply but as of now it would only be \$40).

We say Holistic Health Professional instead of Holistic Health Practitioner to avoid the "practitioner" which may be viewed as a medical designation in the future. The definition of practitioner: "a person actively engaged in an art, discipline, or profession, especially medicine"

Certified could be used to against a person or the organization. "If a customer, patient, or employer is injured by a certified product or professional, it is possible that the certifying organization will be held liable for negligence or negligent misrepresentation." We offer a Certificate in Herbalism, we do not say you are a certified herbalist. We will be adding other certificates in the future.

We do not offer "degrees". The name implies that the credits can transfer to government accredited schools and I find that misleading. We offer professional diplomas to recognize and verify your many hours of study and completion of our program.

Time Limit for the Programs

There is no set time in which the student must complete any individual phase of learning; however, the student must complete the entire program with the following guidelines.

- A two-year time limit applies to the Master Herbalist and Natural Health Consultant programs
- A three-year time limit applies to the Holistic Health Professional and Doctor of Traditional Naturopathy programs.
- A four-year time limit applies to Double-Diploma programs.
- A one-year time limit applies to the certificate programs.

Extension or Leave of Absence

If the student is unable to complete a program within the time limit they may request an Extension (need more time) or a Leave of Absence (emergency or life changing events) by written request (mail or email only). The Extension or Leave of Absence request will be reviewed on an individual basis and the student will be notified of the decision made. All correspondence regarding these conversations or emails will be saved within the Student Profile but will not appear on any public forms or transcripts. All Extensions and Leave of Absence have a time limit of one year.

At Risk for Unsatisfactory Progress

Our Student Administrator will try to contact the student if course work and Study Groups have not been completed within our estimated time limits. This is a courtesy call only. We want to help address any issues with the studies, testing, acquiring books, or motivation and time issues. If we are unable to contact you by phone or email we will use your mailing address with instructions on how to contact our Student Administrator.

Grading Scale

90-100% (A); 80-89% (B); 75-79% (C)

If a student receives a grade below 75% arrangements will be made through the Student Administrator to determine if full retesting is required or if there was an area within the testing that needs clarification and a partial retest is sufficient. We want to see you succeed both in the classroom and professionally in the future.

Graduation Requirements, Diplomas, and Transcripts

A student will be eligible for graduation when the following conditions are fulfilled:

1. Student has completed all required courses and credit hours
2. Student has received a 75% or better in all classes; and
3. Student has met all financial obligations.

Diplomas are shipped when the above criteria is met in full. The first copy of the diploma and transcript are included in the tuition. Additional diplomas or transcripts are \$25.00 each.

Is Genesis School of Natural Health Accredited?

Yes, we are accredited by the American Association of Drugless Practitioners. The AADP is recognized by both, traditional and non-traditional holistic schools and colleges world-wide as an independent accrediting board for alternative health educational institutions and programs.

Will I qualify for Board Certification?

The AADP Certification and Accreditation Board provides full board professional accreditation and certification to both institutes of higher education and professional practitioners. Students who have received their diplomas are encouraged to apply at www.aadp. There is a one-time board certification and application fee of \$285 and a yearly fee of \$150.00 to remain a member with access to all benefits after the first year. A "Certificate of Membership" will be issued at that time.

Can I freely practice as an Herbalist?

Absolutely. Presently, there exists no licensure in the United States for Herbalists. They can freely practice, as long as they do not diagnose or treat or violate any laws in your state that pertain to "practicing medicine - presenting yourself as a doctor" or "nutritional counseling - presenting yourself as a dietician or nutritionist". Below is a site that tracks the states that have implemented nutritional laws.

"Currently herbalists are not licensed in any states in the United States. If there is an exclusive scope of practice nutrition licensing law (red or orange on the map) in a state, then it is illegal for herbalists to provide nutrition counseling unless they obtain a nutrition license, or fall under an explicit exemption, which is rare. Practicing herbalists MUST review the scope

of the nutrition law in their state including all exceptions and exemptions to assess whether they are legally able to use nutrition tools in their practice. Seeking legal advice may help to determine whether laws governing nutrition care would be violated by the use of nutrition tools in an herbalist practice." - <http://www.nutritionadvocacy.org/laws-state#78>

What ALL Natural Health Professionals Do and What We Don't Do:

1. We do not diagnose disease. We analyze and evaluate conditions, symptoms, and lifestyle habits. We do not claim to be a doctor or dietician/nutritionist. We are natural health professionals, herbalists, holistic health professionals...
2. We do not treat a specific disease. We focus on healing the entire body naturally. We address or remove the root causes and practice the healing power of nature.
3. We do not prescribe drugs. We depend on naturally occurring vitamins, minerals, and other nutrients built into the plant structure of whole foods and herbs and practice "do not harm".
4. We maintain the highest standard of professional and personal conduct and abide by all state and local laws.
5. We are willing to consult and seek the talents of other health professionals when needed. We do not practice beyond our ability and we are up to date on all information given to our clients.
6. We take a holistic approach and help the whole person; Spirit, Soul, Body. We teach, guide, and encourage.

What is Traditional Naturopathy?

"Naturopathy is a philosophy which encompasses a view of life, a model for living a full life. The word naturopathy is a Latin-Greek hybrid which can be defined as 'being close to or benefiting from nature.'" — Stewart Mitchell, *Naturopathy: Understanding the Healing Power of Nature*

A Traditional Naturopath does not treat or diagnose "diseases". They do teach and encourage lifestyle changes like diet, exercise, and sleep. Traditional Naturopaths support the body's natural healing processes and use natural approaches such as fasting and detoxification, the use of herbs, aromatherapy, homeopathy, and many other natural health modalities.

Can I practice Naturopathy anywhere after receiving my diploma from Genesis School of Natural Health?

We teach traditional naturopathy which is a natural health art recognized in all 50 states except South Carolina and Tennessee. Since traditional naturopaths do not diagnose or treat they can legally exercise their practice. It is not to be confused with naturopathic medicine that Naturopathic Physicians practice, they are licensed in about 19 states to diagnose and treat. See www.anma.org for details on state legislations.

The practice of Traditional Naturopathy is recognized as a common occupation at the Federal level (U.S. Congress 1928, 1929, 1930 and 30 Federal Court rulings between 1958 and 1978) and as such it is a profession protected under the 14th and 9th Amendments of the U.S. Constitution. Several states have also made this stipulation either by statute or in the Courts.

Can I use the ND title in states where naturopathic Physicians have obtained exclusive licensure?

You must check with your State. We have chosen to use TND as a designation but there are some hostile laws and people that may even frown at the similarity. Genesis gives the option of choosing TND or HHP If you cannot use the ND or TND.

Other designations allowed in States where you cannot bear the ND status would be: Natural Health Practitioner (NHP), Doctor of Natural Medicine (DNM), Naturopathic Practitioner (NP), Holistic Health Practitioner (HHP), Alternative Medicine Diplomate (AMD)

Can I legally give individual nutritional counseling?

As of writing, 23 states require a state license for nutritional counseling, the others do not. All nutritionists can educate, give general natural health guidance and sell nutritional products. We use the designation of Natural Health Consultant to specifically avoid conflict with dietician groups in the political arena.

Interaction with clients will involve conversations about food and drink choices regardless of whether you are designated as a HHP, TND, NHC, MH, or HC. Know your state laws so your language is correct when helping clients and developing written materials like brochures. It is not what you do, it is what you say and write that can get you in trouble.
